8 **GENERAL ORDER 33**

9 Effective July 1, 2017, bankruptcy cases and adversary proceedings venued in the Santa  
10 Rosa Division of this Court <sup>1</sup> shall be assigned as follows:

11 **Del Norte and Humboldt Counties**  
12 **(Eureka Cases - All Cases)**

13 All bankruptcy cases filed on or after July 1, 2017 and venued in Del Norte County or  
14 Humboldt County, and any adversary proceeding associated with such a bankruptcy case, shall  
15 receive a Santa Rosa Division case number and be assigned to Judge William J. Lafferty.

16 **Napa, Sonoma, Mendocino and Lake Counties**  
17 **(Chapter 12 and Chapter 13)**

18 Chapter 12 and 13 bankruptcy cases filed on or after July 1, 2017 and venued in Napa  
19 County, Sonoma County, Mendocino County or Lake County, and any adversary proceeding  
20 associated with such a bankruptcy case, shall receive a Santa Rosa Division case number and be  
21 assigned to Judge Dennis Montali.

22 **Napa, Sonoma, Mendocino and Lake Counties**  
23 **(Chapters 7, 9, 11 and 15)**

24 Chapter 7, 9, 11 and 15 bankruptcy cases filed on or after July 1, 2017 and venued in  
25 Napa County, Sonoma County, Mendocino County or Lake County, and any adversary  
26 proceeding associated with such a bankruptcy case, shall receive a Santa Rosa Division case  
27 number and be assigned to Judge Roger L. Efremsky or Judge Charles Novack.



1 **Abrogation of General Order 27 and Marin County Cases**  
2 **(All Cases)**

3 All bankruptcy cases filed on or after July 1, 2017 and venued in Marin County, and any  
4 adversary proceeding associated with such a bankruptcy case, shall receive a **San Francisco**  
5 **Division** case number and be assigned to Judge Dennis Montali or to Judge Hannah L.  
6 Blumenstiel.<sup>2</sup>
